# **Terms and Conditions of Use Agreement**

#### 1. Initial Provisions

Welcome to <a href="www.medvop.com">www.medvop.com</a>. Medvop is a profit oriented medical tourism agency based in Istanbul, Turkey. This Terms and Conditions of Use Agreement (hereafter referred to as "Agreement") outline the terms governing visitors' and users' (hereafter collectively referred to as "User") access to and use of this website and the information, and other content available on or through this website. Please read this Agreement carefully before using this website. Medvop reserves to amend and vary this Agreement at its sole discretion at any time. User agrees that continued use of this website after such changes take effect will be deemed to constitute an acceptance of new Terms and Conditions of Use Agreement. User further agrees that he/she is at least 18 years of age and not prevented from entering into a binding legal agreement.

By accessing this website User indicate that he/she have read, understood and is bound by this Agreement which it is understood to be the legal equivalent of a written, signed agreement between User and Medvop and equally binding.

## 2. Description of Service

Medvop is a medical tourism agency located in Turkey specializing in referrals for medical treatments, cosmetic surgery, cosmetic dentistry and recuperation packages for international customers. Medvop have researched and gathered publicly available information and ready to present this information to User for his/her personal use to provide assistance in making a more informed decision about the medical procedure.

Medvop does not employ medical professionals and do not attempt to provide professional medical advice about medical procedures and treatments. Through Medvops medical business partners (which are Hospitals and clinics) in Turkey and Medvop offers detailed information about available medical treatments and procedures with recuperation and packages. Medvop facilitates and supplies information about procedures and treatments for Users to make an informed decision on the procedure. Medvop does not recommends any specific doctors or healthcare facility for User's required medical treatment. Rather, Medvop refers Users to a partner medical facility of their choice for the procedure. The partner medical facility will allocate a doctor or other health professional to User's case. Nothing in Medvop's website shall be deemed as formulation of a diagnosis or the prescription of a treatment. Medcop encourages and advises Users to discuss all medical issues and potential procedures together with their medical doctor in their home country before making a final decision regarding medical treatment in Turkey.

Users assume all responsibility for agreeing to the choice of doctor or other medical professional for their required procedure. Medvop assumes no responsibility or liability of any kind for medical advice and procedures provided or conducted by medical services or facilities that appear on its website. All medical services rendered are the responsibility of the medical service or facility that provides the services and are governed solely by the terms and conditions of the medical facilities User may enter.

Medvop provides options for travel logistics and accommodation for Users. If travel logistics or accommodation or both options are not selected, Medvop assumes no responsibility for options not selected by Users.

## 3. Prices, Referral and Payment Procedure

All prices shown in Medvop's website are subject to alter at any time before booking.

Medvop shall arrange a quotation for the User after receiving relevant medical history, photographs and visuals from User. Medvop recommends Users to ask all the questions that they may have, during this period. These initial consultations are complementary, and User has no obligation to pay for this service until deposit is paid.

When a User accepts Medvop's quotation and decides to enter into a agreement with Medvop by signing an agreement, a non-refundable deposit of 10% to 25% of the quote must be paid to Medvop within a period of 10 days for the agreement to remain valid via Western Union. The remaining 75% should be paid to Medvop prior to the User's arrival unless special provision has been made for the balance to be paid in cash (Bank charges for transfers include an additional 18-20%) on arrival at the chosen medical facility.

The procedure will be carried out in a hospital, dental surgery or other medical facility, and the surgeon, doctor or dentist will consult with User and undertake a careful examination before User finally commits itself to the procedure.

The User should be aware of the fact that the value of the quote initially approved may, in exceptional cases, suffer alterations and be modified after the first evaluation and mandatory consultation with the medical professional who will be performing the procedure. Any alteration will be fully explained and justified to the Client, who must agree and approve the additional costs, before any procedure is performed.

The Client assumes responsibility to pay extra medical expenses related to any unforeseen and additional treatment intended for the safety and health during the medical procedure or in the postoperative period. Medvop has no involvement or responsibility in such cases.

#### 4. Alterations / Cancellations

The alteration or cancellation of any of the services must be requested by the Client in writing via email, and the Client will be responsible for any costs originated by such alterations or cancellations. The 25% deposit is not refundable for changes of mind or cancellation by the User. In the event of extenuating circumstances such as the death of an immediate family member, the Client should submit a request for consideration of refund of the deposit amount in writing to Medvop. Medvop is under no obligation to agree to requests for a refund of deposit monies in these circumstances, and any decision made by Medvop is final.

If, at the point of User's pre-procedure consultation, User's medical professional decides not to proceed with the treatment or procedure, User shall be refunded the balance of the deposit remaining after the cost of any pre-procedure tests and consultations have been deducted.

The Client should be aware of the fact that each service provider (medical, accommodation and others) has its own alteration and cancellation policy and, therefore, Medvop has no control over the fees that might be charged by them.

In the unusual event of any delays on the part of the provider or, indeed, the provider being unable to fulfil its selected services, Medvop will make every effort possible in order to try and solve the issue but will not be held responsible for the situation, nor for any of the costs incurred. Medvop acts solely as an intermediary service between the Client and providers and, therefore, accepts no responsibility, nor will be expected to assume any costs arising from circumstances caused by force of nature or, indeed, any other circumstances beyond their control.

If the Company has to cancel or significantly change the Client's booking, the Company will contact the Client to discuss this and the Client can choose to rearrange the procedure or cancel it and get a full refund. However, Medvop will not pay compensation in these circumstances and is not responsible for any losses or expenses the Client suffer as a result of circumstances beyond its control.

The Company cannot accept responsibility for clients missing aircraft due to late arrival of connecting aircraft or for late check-in at the airport.

If User's plans to travel to Turkey are affected by a global health crisis (such as COVID-19), User may reschedule the procedure date with no penalty for alteration, however the deposit will be retained by Medvop until such time trip is rescheduled.

It is User's responsibility to be in possession of a valid passport, visa permits, vaccinations, preventative medicines and other medical certificates and all necessary travel documents. User shall check the visa requirement at time of booking using the official Turkish government website: https://www.evisa.gov.tr/en/

Medvop is not liable for damages arising from changes in regulations or laws to the necessary travel document requirements. Medvop may provide advice about these matters in good faith, however without liability. Medvop is not responsible if User is refused to entry to the Republic of Turkey because User lacks the correct passport, visa or other documentation.

Other than as expressly provided in these Terms and Conditions, Medvop does not make any promises or guarantees about the services rendered by us, and will not be held liable under any circumstances, whether directly or indirectly, for any damages resulting from the use of this site, any site materials, Medvop's services, or any services obtained on or through this website.

By using this website, User agrees that all damages, costs and fees, including legal fees, fines, lost wages or profits, delays, and penalties that arise from the any direct or indirect use of this website is solely his/her responsibility. The Emergency Arbitrator Rules shall not apply. The place of the arbitration shall be İstanbul, Turkey. The language of the arbitration shall be English. Sole arbitrator shall govern arbitration. The law applicable to the merits of the dispute shall be law of the Republic of Turkey.

### 12. Final Provisions

All notifications, notices and correspondence to be made to the User shall be made through the contact information registered by the User in the system. If the User requests a change in this contact information, the User must notify Medvop immediately. If the relevant change request is not forwarded to Medvop, notifications, notifications and correspondence to the old addresses will be valid and Medvop will not be held responsible for any damages arising therefrom.
